ORDER

1. Provisional Affiliation for starting MBA programme with an intake of 60 students at Elijah Institute of Management Studies, Ponganamkad, Thrissur during 2004-05 was granted vide U.O. read as 1st.
2. Provisional affiliation to additional batch of MBA programme with an intake of 60 seats has been granted to the college for the AY 2024-25 vide paper read as 2nd.
- 3.Continuation of Provisional Affiliation was granted vide UO read as 3rd for the AY 2025-26 on conditional basis subject to the submission of renewal NOC. Now the Principal has forwarded the renewal NOC vide paper read as 4th.
4. The Principal, Elijah Institute of Management Studies, Ponganamkad, Thrissur has requested for Continuation of Provisional Affiliation to MBA programme with an intake of 120 seats (2 batches of 60 seats each) for the academic year 2026-27 vide paper read as 5th above by remitting required administration/affiliation fee.The college has not submitted the renewal NOC 2026-27.
5. AICTE, vide paper read as 6th, has extended its approval to the MBA programme with 120 seats for the academic year 2026-27.
6. Considering the above, sanction has been accorded by the Vice Chancellor
 - (i) to grant Continuation of Provisional Affiliation to MBA programme with an intake of 120 seats at Elijah Institute of Management Studies, Ponganamkad, Thrissur for the academic year 2026-27 on conditional basis subject to the submission of renewed NoC from Government of Kerala for 2026-27.
 - (ii) to make the U.O read as 3rd, as absolute since the College has produced the renewed NOC for 2025-26.
7. Orders are issued accordingly with the following terms and conditions:

1) Affiliation granted is strictly provisional and only for the academic year 2026-27. The college must apply for CPA for the ensuing years by remitting the fee fixed by the University from time to

time, along with the extension of approval orders, if any, from the apex bodies concerned.

2) The institution must strictly adhere to the Supreme Court directions in (WP (C) 656/1998) regarding ragging prevention ; failure to do so will lead to withdrawal of affiliation. Additionally, the college must comply with all conditions stipulated in the renewed NOC from the Government of Kerala for the 2026-27 academic year.

3) Admissions for the next academic year shall only be made after obtaining prior permission from the University. No student shall be admitted in anticipation of affiliation , and all selections must strictly follow University/Government rules and regulations.

4) All colleges must comply with the relevant regulations & Syllabi . The Principal must ensure that only the syllabi approved by the University and available on the official website (www.uoc.ac.in) are followed.

5) To offer a Double Major pathway, the college must ensure sufficient workload. However, if a college wishes to offer a new Double Major programme (not previously sanctioned), it must formally submit application as per the existing regulations.

6) The courses sanctioned in this order shall not be used as a basis for calculating subject workload or for claiming additional teaching faculty. Separate competent orders must be obtained from the Government/University for such requirements.

7) The conduct of University examinations (including CDOE Examinations) is compulsory and binding. Examinations are only permitted if the college has been granted continuation of provisional affiliation or if their application is currently under process.

Violation of any of the above may lead to the cancellation of affiliation.
